Tanggung Jawab Sosial dan Lingkungan

CORPORATE SOCIAL RESPONSIBILITY

Sebagai perusahaan publik, Perseroan tidak hanya terfokus pada penciptaan nilai tambah bagi para pemegang saham, tetapi juga memiliki perhatian yang besar terhadap tanggung jawab sosial atau *Corporate Social Responsibility (CSR)*. Sepanjang tahun 2013 Perseroan telah mengimplementasikan program CSR dalam bentuk *community development* dan *community engagement* senilai Rp1.542.952.258.



As a public company, the Company not only focuses on creating added values for the shareholders through service improvement, but also pays high attention to the implementation of Corporate Social Responsibility (CSR). During 2013, the Company CSR program was carried out in two forms of activities, namely community development and community engagement amounted Rp1,542,952,258.

Perseroan menyadari sepenuhnya bahwa untuk dapat terus maju dan berkembang secara berkelanjutan, diperlukan kerja keras sehingga dapat menghasilkan peningkatan laba dalam setiap aktivitas bisnisnya. Namun demikian, Perseroan memahami bahwa keberlanjutan dan keuntungan bisnis tersebut tidak bisa dipisahkan dengan peran masyarakat dan lingkungan di sekitar wilayah operasi Perseroan, terutama di 3 (tiga) kecamatan yaitu Tanjung Priok, Pademangan dan Penjaringan yang meliputi 8 (delapan) Kelurahan yaitu Sunter Jaya, Sungai Bambu, Warakas, Papanggo, Pademangan Timur, Ancol Timur, Penjaringan dan Pejagalan.

Perseroan selalu konsisten untuk menjaga eksistensi bisnisnya dengan berlandaskan pada keseimbangan konsep *Triple Bottom Lines*, yaitu *People, Planet and Profit*, sebagai landasan fundamental dalam menjaga keberlanjutan bisnis yang dijalankan.

Implementasi program CSR yang mengedepankan hubungan baik dengan pemangku kepentingan eksternal serta lingkungan terus dibangun secara konstruktif dengan pendekatan *emotional appeal* yang terarah. Seluruh upaya tersebut diyakini mampu menjadi *trigger* yang tidak hanya berdampak positif bagi keamanan aset jalan tol Perseroan, tetapi juga bagi peningkatan reputasi Perseroan.

Selain untuk pemenuhan kewajiban perusahaan terhadap Undang-Undang No. 40 tahun 2007 tentang Perseroan Terbatas, implementasi program CSR Perseroan juga merupakan salah satu kunci strategis yang akan menunjang kelancaran dan keberhasilan operasional Perseroan. Dalam menjalankan program CSR tersebut, Perseroan selalu melakukan *monitoring* dan evaluasi agar program-program yang sedang dan sudah dijalankan, tepat peruntukannya dan sasarannya.

Bentuk nyata implementasi program CSR Perseroan sepanjang tahun 2013 telah menyerap biaya sebesar Rp1.542.952.258 (satu miliar lima ratus empat puluh dua juta sembilan ratus lima puluh dua ribu dua ratus lima puluh delapan rupiah) atau meningkat +/- 11% dibandingkan tahun 2012 sebesar Rp1.375.000.000. Peningkatan ini membuktikan kesungguhan Perseroan dalam melaksanakan tanggung jawab sosialnya yang dirumuskan melalui 5 (lima) pilar CSR Perseroan yaitu:

The Company is fully aware the importance of hard work in sustaining the business growth, so as resulting the higher profitability in each business activities. The Company understands that business continuity shall not be accomplished without the active role from the community and environment around the business locations of the Company, particularly those who live in 3 districts, namely Tanjung Priok, Pademangan and Penjaringan, which cover 8 (eight) sub-districts, they are, Sunter Jaya, Sungai Bambu, Warakas, Papanggo, Pademangan Timur, Ancol Timur, Penjaringan and Pejagalan.

The Company consistently maintained its business existence based on the balanced concept of Triple Bottom Lines, named People, Planet and Profit, as the strong fundamental to sustain its business.

The implementation of CSR programs which are emphasized on the good relation with the external stakeholders and the environment are consistently developed in constructive way with the approach of focused emotional appeal. All of the efforts are believed to trigger positive impacts not only on the security of the Company toll road assets but also on the image of the Company.

Not only to fulfill the requirement of Law No. 40 of the Year 2007 about the Limited Liability Company, the Company to CSR implementation also serves as one strategic key to support its business operation. Therefore, in doing so, the Company conducts monitoring and evaluation towards the ongoing and completed programs, in order to ensure the target achievement.

During 2013 the CSR programs absorbed Rp1,542,952,258 (one billion five hundred forty two million nine hundred fifty two thousand two hundred and fifty eight rupiah), an 11% rise compared to Rp1,375,000,000 allocated in 2012. The increased amount reaffirmed the commitment of the Company to carry out the social responsibility, which was strongly established through 5 (five) pillars:



1. Bidang Pendidikan

a. CMNP Dukung Peringatan Hari Anak Nasional 2013

Dalam rangka mendukung peringatan Hari Anak Nasional, Perseroan mengadakan acara di kolong tol RW 013 Penjaringan, Sabtu (9/8/2014). Acara dihadiri oleh kurang lebih 2.000 anak serta diisi dengan berbagai kegiatan seperti menyanyi dan menari dari Kelompok Belajar Anak (KBA). Pelaksanaan acara ini merupakan wujud apresiasi Perseroan atas minat anak-anak di wilayah tersebut.

b. CMNP Bagikan 1.000 Tas Ransel Kepada Penyandang Disabilitas

Sebanyak 1.000 orang penyandang keterbatasan atau disabilitas (tuna netra, tuna grahita, autisme dll) merayakan peringatan Hari Disabilitas Internasional 2013 di halaman Kantor Walikota Jakarta Utara, Selasa (3/12/2013). Pada acara yang diselenggarakan oleh Sudin Sosial Kota Administrasi Jakarta Utara dan didukung oleh beberapa perwakilan dunia usaha tersebut, Perseroan membagikan 1.000 tas ransel untuk tempat perbekalan mereka rekreasi di Dunia Fantasi, Taman Impian Jaya Ancol.

c. CMNP Tandatangani Deklarasi Jakarta Kota Layak Anak

Perseroan dan PT Astra International Tbk adalah dua perwakilan dunia usaha yang turut serta menandatangani Deklarasi Jakarta Menuju Kota Layak Anak bersama Gubernur DKI, Joko Widodo, di Kelurahan Sungai Bambu, Selasa (17/12/2013). Pada acara yang juga dihadiri oleh 2.000 anak sekolah itu, PT TMMIN dan CMNP menyampaikan komitmennya akan membangun Taman Interaktif seluas 3.000 m² bertempat di RW 06 Kelurahan Sungai Bambu.

d. CMNP Peduli PAUD

Perseroan memberikan bantuan pengadaan dan pemeliharaan sarana Pendidikan Anak Usia Dini (PAUD) yaitu PAUD Wijaya RW 013 Pejagalan, Paguyuban PAUD Warakas dan PAUD Matahari II Sunter Jaya. Pada tahun 2011, ketiga PAUD tersebut merupakan bagian dari 22 PAUD yang menjadi target Perseroan dalam Program Revitalisasi PAUD di Jakarta Utara.

1. Education

a. CMNP Supports the Celebration of National Kids' Day 2013

In order to support the celebration of National Kids' Day, the Company held an event under the toll bridge of RW 013 Penjaringan, on Saturday (9/8/2014). About 2,000 kids joined in the event that was fulfilled with variety of activities, such as singing and dancing from Kids Learning Group. The event represented the Company appreciation to the spirit of the kids there.

b. CMNP Distributes 1,000 backpacks to Disabled People

Around 1,000 disabled people (the blind people, deaf, autism, etc) celebrated International Disability Day 2013 at the ground area of the Office of North Jakarta Mayor, on Tuesday (2013). In the event, which was held by the North Jakarta City Social Care Office and supported by some business representatives, the Company distributed 1,000 backpacks to carry their food supply during vacation to Dunia Fantasi, Taman Impian Jaya Ancol.

c. CMNP Signs Declaration of Jakarta The Decent City for Kids

The Company and PT Astra International Tbk were among the business representatives that joined in the signing of Declaration of Jakarta The Decent City for Kids together with Jakarta Governor Joko Widodo, at Sungai Bambu Sub-District on Tuesday (12/17/2013). In the event in which 2,000 students were also participated, PT TMMIN and the Company presented its statements to build an interactive park on a 3,000-sqm area at RW 06 of Sungai Bambu Sub-District.

d. CMNP Cares for PAUD

The Company provided aid in the forms of maintenance of PAUD (Education for Early Childhood) facility, namely PAUD Wijaya RW 013 Pejagalan, Paguyuban PAUD Warakas and PAUD Matahari II Sunter Jaya. Those three PAUDs were part of 22 targeted PAUDs for PAUD Revitalization Program in North Jakarta.

2. Bidang Sosial

a. CMNP Berikan Bantuan Korban Banjir

Perseroan memberikan bantuan bagi korban banjir di 9 (sembilan) kelurahan koridor jalan tol Ir. Wiyoto Wiyono, MSc., Jum'at (18 Januari 2013). Bantuan berupa 2.500 nasi bungkus, 75 box mie *instant* dan 25 box air mineral dibagikan langsung di posko-posko banjir setempat. Bantuan banjir juga diberikan Perseroan kepada warga di Perumahan Puri Nusaphala Jatiasih Bekasi, Rabu (17 April 2013) berupa nasi bungkus, selimut, obat-obatan, serta sejumlah karung pasir untuk menutup sementara tanggul air yang jebol dan mengakibatkan kawasan perumahan karyawan tersebut terendam air hingga 100 cm.

b. CMNP Berikan Santunan Korban Ledakan Gas dan Kebakaran

Kepedulian Perseroan juga dikembangkan di luar wilayah bisnisnya, yaitu pemberian bantuan dana pendidikan kepada Ridho Januar (5 tahun), salah satu korban ledakan gas di Tangerang, Sabtu (26 April 2013). Perseroan juga memberikan bantuan kepada 11 rumah warga korban kebakaran di RW 04 Kelurahan Pejagalan, Kecamatan Penjaringan, berupa bahan bangunan, pada Senin (30 September 2013).

c. CMNP Gelar Buka Puasa Gratis dan Ta'jil Gratis

Perseroan menggelar acara Buka Puasa Gratis untuk kedua kalinya di halaman Gedung Citra Marga (10 – 30 Juli 2013). Acara sosial selama bulan Ramadhan tersebut diikuti sebanyak 750 peserta setiap harinya atau sebanyak 11.250 orang selama pelaksanaan kegiatan berlangsung. Kegiatan Buka Puasa Gratis ini melibatkan *vendor* dari unsur wirausaha yaitu pedagang kaki lima yang berdomisili di sekitar kantor Perseroan.

Selain menggelar Buka Puasa Gratis, Perseroan juga menyelenggarakan Ta'jil Gratis di 18 gerbang jalan tol Ir. Wiyoto Wiyono, MSc. (8 Juli – 8 Agustus 2013). Sebanyak 2.200 paket ta'jil dibagikan setiap harinya kepada pemakai jalan atau 41.900 paket selama event. Acara ini terselenggara atas kerja sama antara Perseroan dengan Radio El-Shinta, Radio Sonora dan beberapa sponsor lain.

d. CMNP Peduli Dhuafa

Perseroan memberikan santunan berupa 2.500 paket sembako untuk kaum dhuafa yang berdomisili di 8 kelurahan sepanjang koridor jalan tol pada Selasa (30 Juli 2013). Santunan yang diberikan secara rutin setiap bulan Ramadhan tersebut merupakan bentuk kepedulian Perseroan, terutama dalam meringankan beban warga atas tingginya harga pangan menjelang Lebaran. Selain peduli dhuafa, Perseroan juga menyerahkan donasi kepada Bazis Jakarta Utara.

e. CMNP Berikan Bantuan Hewan Kurban

Perseroan kembali menyalurkan bantuan hewan kurban berupa 8 (delapan) ekor sapi dan 8 (delapan) ekor kambing

2. Social

a. CMNP Gives Donation to Flood Victims

The Company distributed aids for flood victims in 9 (nine) sub districts along the corridor of Ir. Wiyoto Wiyono, MSc. toll road, on Friday (January 18, 2013). The aids which consisted of 2,500 rice boxes, 75 boxes of instant noodles, and 25 boxes of mineral water were directly distributed to the flood refugee posts. The Company also provided donation for residents of Perumahan Puri Nusaphala Jatiasih Bekasi, on Wednesday (April 17, 2013) which consisted of rice boxes, blankets, medication, as well as sand bags to help support the broken-down water dam that had caused flood with the height up to 100 cm in the area of its employees' residential.

b. CMNP Provides aids for Victims of Gas Explosion and Fire Incidents

The Company expanded its concern to the needs outside its business area by providing education fund aid for Ridho Januar (5 years old), a victim of gas explosion incident in Tangerang, on Saturday (April 26, 2013). The Company also distributed aids for 11 houses of fire incident victims at RW 04 Pejagalan sub-district, Penjaringan district, on Monday (September 30, 2013). The aids were in form of building material.

c. CMNP Serves Free Breakfasting and Ta'jil

The Company served a free breakfasting and ta'jil for second time at ground area of Citra Marga Building (10-30 July 2013). The social event held during Ramadhan took participation of 750 people every day or 11,250 people during the event. The free breakfasting event involved street vendors whose domicile was around the Company head office.

Adding to it, the Company also distributed free ta'jil at 18 gates along the Ir. Wiyoto Wiyono, MSc. toll road (8 July – 8 August 2013). About 2,200 ta'jil packages were distributed every day to the toll road users or equal to 41,900 packages during the event. The event was sponsored by El-Shinta Radio, Sonora Radio and other sponsors.

d. CMNP Cares for the Poor

The Company distributed 2,500 daily need packages for the poor families whose domicile in 8 sub-districts along the toll road corridor on Tuesday (30 July 2013). The donation which was given regularly in every Ramadhan represented the Company concern particularly in anticipating the hike of food prices approaching Lebaran Day. Besides, the Company also gave donation through Bazis in North Jakarta.

e. CMNP Donates Qurban Meat

The Company donated 8 (eight) cows and 8 (eight) goats for qurban at Mosques and Mushollas along the corridor

pada Masjid dan Mushola di koridor jalan tol Ir. Wiyoto Wiyono, MSc., serta masjid di perumahan karyawan Puri Nusaphala Jatiasih-Bekasi, Sabtu (12 Oktober 2013).

3. Bidang Kesehatan

a. CMNP Dukung Warakas Sebagai Juara Lomba Kampung Bebas Narkoba

Perseroan memberikan dukungan berupa 500 T-shirt kepada Tim Sukses Warakas dalam Lomba Kampung Bebas Narkoba 2013 Tingkat Provinsi DKI Jakarta. Di ajang yang diikuti oleh 27 kelurahan tersebut, akhirnya Warakas ditetapkan sebagai Juara I, diikuti Kelurahan Cibubur (Juara II) dan Kelurahan Kalideres (Juara III). Warakas yang merupakan wilayah binaan CSR Perseroan dinilai paling berhasil menjalankan kegiatan anti narkoba, termasuk perannya dalam merehabilitasi para pemakai narkoba. Proses penjurian dilakukan oleh Tim Badan Narkotika Nasional (BNN) di Warakas, Sabtu (9 November 2013).

b. CMNP Dukung Bulan Dana PMI Tingkat Kota Administrasi Jakarta Utara

Perseroan mendukung Program Bulan Dana Palang Merah Indonesia Kota Administrasi Jakarta Utara. Dukungan Perseroan kepada PMI, rutin diberikan setiap menjelang tutup tahun.

c. CMNP Dukung Kegiatan Donor Darah, Posbindu dan PHBS

Perseroan mendukung Karang Taruna kelurahan Sungai Bambu dalam penyelenggaraan kegiatan Donor Darah Remaja di kelurahan Sungai Bambu, Jum'at (11/10/2013). Perseroan juga mendukung Posbindu (Pos Pembinaan Terpadu) Anyelir SDN Kalibaru 10 Pagi kelurahan Kalibaru Cilincing, Jum'at (21/06/2013). Posbindu merupakan bentuk pelayanan yang melibatkan peran serta masyarakat melalui upaya promotif dan preventif untuk mendeteksi dan mengendalikan secara dini keberadaan faktor risiko Penyakit Tidak Menular (PTM). Selain Donor Darah dan Posbindu, Perseroan juga mendukung kegiatan PHBS (Perilaku Hidup Bersih dan Sehat) di kelurahan Warakas, Jum'at (14/06/2013). PHBS merupakan gerakan perilaku yang dilakukan atas kesadaran untuk anggota keluarga, agar dapat menolong dirinya sendiri di bidang kesehatan dan berperan aktif dalam kegiatan-kegiatan kesehatan di masyarakat.

4. Bidang Lingkungan

a. CMNP Antarkan Kelurahan Sungai Bambu Juara Lomba Bulan Bakti Gotong Royong Masyarakat (BBGRM) Tingkat Nasional

Perseroan mendukung keikutsertaan kelurahan Sungai Bambu dalam lomba Bulan Bakti Gotong Royong Masyarakat (BBGRM) Tingkat Nasional di Banjar Baru Kalimantan Selatan, Kamis (30/5/2013). Pada ajang tersebut Kelurahan Sungai Bambu yang mewakili Provinsi DKI Jakarta, ditetapkan sebagai Pemenang Pertama, menyisihkan 33 provinsi lainnya.

of Ir. Wiyoto Wiyono, MSc. toll road and the mosque at Puri Nusaphala, the employees' residential complex, at Jatiasih – Bekasi, on Saturday (October 12, 2013).

3. Health

a. CMNP Supports Warakas as the Champion of Free – Drug Kampung Competition

The Company gave away 500 T-shirt as its support for Success Team for Warakas Area to win at Free-Drug Kampung Competition 2013 of DKI Jakarta Province. At the competition which took participation of 27 sub-districts, Warakas sub-district finally won the first place, followed by Cibubur sub-district at the second place and Kalideres sub-district at the third place. Warakas, which is one of target areas of Company CSR activities, was considered successful in its anti-drug campaign, including activity for rehabilitating the drug users. The judges were of National Narcotics Agency and the process took place at Warakas, on Saturday (9 November 2013).

b. CMNP Supports North Jakarta's Indonesian Red Cross Fund Program

The Company supported the Month of Indonesian Red Cross Fund of North Jakarta. The Company support for Red Cross activities is regularly held towards end of the year.

c. CMNP Supports Blood Donor, Posbindu and PHBS

The Company supported the youth organization of Sungai Bambu sub-district in organizing Youth Blood Donor at Sungai Bambu sub-district, on Friday (10/11/2013). The Company also supported Posbindu (Integrated Counseling Post) Anyelir of SDN Kalibaru 10 Pagi at Kalibaru Cilincing sub-district, on Friday (06/21/2013). Posbindu is a service that requires active participation from the society through promotive and preventive actions to detect and control risk of disease. Besides organizing Blood Donor and Posbindu, the Company also held Clean and Healthy Life Movement activity a Warakas sub-district, on Friday (06/14/2013). This activity encouraged awareness for each family member so as to help themselves regarding health and play active role in public health activities.

4. Environment

a. CMNP Takes Sungai Bambu sub-district to Win National Bulan Bakti Gotong Royong Masyarakat (BBGRM) Competition

CMNP supported Sungai Bambu Sub-District to participate in National Public Mutual Cooperation Program at Banjar Baru, South Kalimantan, on Thursday (5/30/2013). At the event, Sungai Bambu sub-district which represented Special Capital Region of Jakarta won the first place, thus leading over the other 33 provinces.

b. CMNP Bagikan 500 Pohon pada acara Bulan Bakti Gotong Royong Masyarakat (BBGRM) X DKI Jakarta

Perseroan memberi bantuan berupa 500 pohon produktif kepada Pemerintah Kota Jakarta Utara, pada acara BBGRM X Tingkat DKI Jakarta, di Kolong Tol RW 013 Kelurahan Penjaringan, Rabu (12/6/2013). Penanaman pohon secara simbolis ini dilakukan oleh Gubernur DKI Jakarta, Joko Widodo, dan para Walikota se DKI Jakarta. Selain menanam pohon, Joko Widodo juga memberikan penghargaan CSR kepada para pelaku usaha termasuk Perseroan, serta penghargaan bagi para pemenang Lomba 10 Program PKK Tingkat Provinsi DKI Jakarta.

c. CMNP dan Astra Group Gelar Uji Emisi Gratis

Perseroan dan Astra Group kembali menggelar kegiatan Uji Emisi Gratis di Rest Area Gerbang Tol Tanjung Priok I, (23-24/4/2013). Sebanyak 1.200 kendaraan pemakai jalan tol mengikuti kegiatan tersebut. Kegiatan yang juga didukung oleh AstraWorld, Auto 2000, Astra Credit Company (ACC) dan Shell ini, merupakan sinergi untuk ketiga kalinya sejak keanggotaan Perseroan dalam Apresiasi Emisi Bersih (AEB) pada tahun 2004.

Selain merupakan wujud program CSR Perseroan dan *Environment and Social Responsibility* Astra Group terhadap perbaikan kualitas lingkungan, kegiatan ini diharapkan juga mampu meningkatkan pelayanan kepada pemakai jalan tol Ir. Wiyoto Wiyono, MSc.

d. CMNP Dukung Program “Stop Nyampah di Kali”

Perseroan mendukung program “Stop Nyampah di Kali Ke-6” Tahun 2013 yang diselenggarakan oleh Badan Pengelola Lingkungan Hidup Daerah (BPLHD) Propinsi DKI Jakarta dalam rangka memperingati hari lingkungan hidup, Kamis (5/6/2013). Kegiatan ini merupakan bagian dari program sosialisasi kepada masyarakat agar tidak membuang sampah di kali.

e. CMNP Jadi Tuan Rumah Rakor CSR

Perseroan menjadi tuan rumah Rapat Koordinasi “Sinergi Program Pemerintah dan CSR Perusahaan se Jakarta Utara” bertempat di Gedung Citra Marga, Kamis (28/11/2013). Rakor yang dihadiri Wakil Walikota Jakarta Utara beserta jajarannya seperti para Camat, Lurah serta para perwakilan dunia usaha se Jakarta Utara ini digelar rutin setiap 3 bulan untuk mengkomunikasikan program-program CSR agar dapat diselaraskan dengan program pemerintah dan kebutuhan masyarakat setempat.

5. Bidang Sarana dan Prasarana

a. CMNP Menyediakan Lapangan Futsal

Perseroan kembali menyediakan lapangan futsal bertempat di kolong tol RW 10 dan RW 13 Kelurahan Penjaringan, Jum'at (30/8/2013). Penyediaan sarana olah raga di kolong

b. CMNP Distributes 500 trees at the event of Bulan Bakti Gotong Royong Masyarakat (BBGRM) X DKI Jakarta

The Company donated 500 productive trees to Government of North Jakarta City at BBGRM X event held under the bridge area of RW 013 at Penjaringan sub-district, on Wednesday (6/12/2013). Symbolically, the tree was planted by Governor of Special Capital Region of Jakarta, Joko Widodo, and the mayors of Jakarta. Besides the tree planting, Joko Widodo also granted a CSR award to the entrepreneurs including the Company, as well as handed over awards to the winners of 10 PKK Programs competition throughout Special Capital Region of Jakarta.

c. CMNP and Astra Group Hold Free Emission Test

The Company and Astra Group again held the free emission test at Rest Area of Tanjung Priok I Toll Gate, (23-24/4/2013). Around 1,200 vehicles of the toll road users participated in the event. The event which was supported by AstraWorld, Auto 2000, Astra Credit Company (ACC) and Shell represented the third synergy of the Company since being the member of Clean Emission Appreciation in 2004.

Not only as one of the CSR activities of the Company and Environment and Social Responsibility of Astra Group towards the improvement of environment quality, the activity was aimed at improving service to the users of Ir. Wiyoto Wiyono, MSc. toll road.

d. CMNP Supports “Stop Nyampah di Kali”

The Company supported the 6th “Stop Nyampah di Kali” program in 2013 which was held by Local Environmental Management Agency of Special Capital Region of Jakarta in celebrating the environment day, on Thursday (6/5/2013). The activity was a socialization program to the society to prevent them from throwing household waste into the river.

e. CMNP Hosts CSR Coordination Meeting

The Company hosted the Coordination Meeting themed “Program Synergy between Government and CSR of Companies in North Jakarta” at Citra Marga Building, on Thursday (11/28/2013). The coordination meeting which was attended by North Jakarta Deputy Mayor and his staffs, including District Heads, Sub-District Heads, and business representatives, was a routine program held in every three months to communicate CSR programs to be made in line with the government programs and the needs of the local communities.

5. Provision of Facilities
